This document is Hope Church Gravesend COVID-19 Risk Assessment, review number 6.

Purpose of this review: To take account of government guidance applicable under Step 4 on the roadmap to recovery from 19/07/2021, (updated 16/07/2021). (click here to read the guidance)

At Step 4 all legal rules affecting places of worship in relation to covid-19 ceased to apply. Instead there is a greater emphasis on using personal judgement to manage our own risks.

The trustees of the church have an on-going legal duty to manage risks to those affected by their business or organisation, by carrying out a health and safety risk assessment, including the risk of infection by COVID-19, and to take reasonable steps to mitigate the risks identified.

On 21/07/2021 the leaders met and resolved the following:

DECISION: The leaders will continue to take the following ongoing measures, for the following reasons:

- 1. There is a high degree of uncertainty about the impact of the current increase in covid-19, (especially delta variant), along with uncertainty about the effects of the relaxation of restrictions after 19 July, and the situation is likely to be clearer in 6 weeks or so;
- 2. Not all adults will have had the opportunity to be double vaccinated, and again the ongoing impact of the pandemic on different groups should be clearer in some weeks time.

PROPOSAL:

- To retain 2 metre distancing facilitated by pre-booking.
- To allow face coverings to be dispensed with while seated, but to wear them when moving from seating at start and end of service or mingling. i.e. if interaction is at a distance of less than 2m. (This is not entirely a new idea, and has been used in other contexts, such as restaurants etc.)
- To recommence congregational singing as part of our worship
- To encourage fellowship/mingling outside the building

OUTCOME:

- Implement the above
- Update the covid-19 Risk Assessment
- Regularly review and implement further changes as required and as the situation develops.

Infection by airborne virus	All attendees	FACE COVERINGS: Worn to reduce the risk of infection by persons infected with the virus but with no symptoms.	Face coverings are no longer required by law. The Government expects/ recommends that people wear face coverings in "crowded" areas. Continuing with social distancing ensures our services are not 'crowded', and even with the entire regular congregation present we are some way from the building capacity. The trustees have decided to advise wearing face coverings when moving past other people, en route to their seat. When seated the face covering may be removed. This includes when standing for congregational singing. When circumstances involve closer physical proximity, e.g. seating arranged at less than 2 metres for special services, or gathering around in one area of the room such as for baptisms, the trustees decision is that face coverings should then be worn. It is recognised that not everyone will wish to remove their face covering, or be seated near to those who have done so.
